THE DOCYARD PRESENTS *SCENES OF A CRIME* AT THE BRATTLE THEATRE, APRIL 2

Award-winning True Crime Documentary Dissects Truth-telling during a Long Police Interrogation

CAMBRIDGE, MA — The DocYard, Boston's premiere showcase for documentary film, is proud to present *Scenes of a Crime (2011)*, a New York Times Critic's Pick and incisive documentary film by Blue Hadaegh and Grover Babcock. *Scenes of a Crime* explores a nearly 10-hour police interrogation that culminates in a disputed confession and an intense, high profile murder trial in New York State. The film will screen April 2 at 8pm at the historic Brattle Theatre followed by an exclusive, in-person Q&A with filmmakers Blue Hadaegh and Grover Babcock.

When Adrian Thomas became the main suspect for alleged “shaken baby” abuse that may have led to the death of his four-month-old baby, he did not know that he was being videotaped while detectives attempted to manipulate his responses. Having waived his Miranda rights, Thomas first denied harming his child. As the interrogation continued into the next several hours, the detectives repeatedly lied and used a variety of psychological techniques to ramp up the pressure and eventually extract a highly disputed confession, all of which reveals the complexity of truth and the definition of evidence in the American justice system.

In this mysterious and disturbing true crime documentary, various participants – detectives, prosecutors, witnesses, jurors and the suspect himself – offer conflicting accounts of the events leading to the death of the child. *Scenes of a Crime* is a compelling documentary in which real-life police video recordings allow directors Blue Hadaegh and Grover Babcock to unravel and illustrate the complicated psychological dynamic between detectives and their suspect during interrogations.
